<u>Village of South River</u> Council Meeting – Feb 1, 2024

The special meeting of the Council of the Village of South River was held virtually and in person on Thursday February 1, 2024. A quorum was present. In attendance were Mayor Jim Coleman (Chairing in person in Council chambers), Deputy-Mayor Bill O'Hallarn, Councillor Teri Brandt, and Councillor Robert Brooks. Councillor Brenda Scott was absent with notice.

1.Call to Order - The Meeting was called to order by Mayor Jim Coleman at 2:00 pm.

2. Declaration of Pecuniary Interest and General Nature Thereof - Nil

3. Purchase of Used Snow Plow-

Council discussed the failure of the 2011 Freightliner Snowplow. The estimated repair from Freightliner is approximately \$80,000 including tax. Local suppliers are trying to source a used engine and alternate supplier to install at a reduced cost. Chief Public Works Operator has sourced another complete 2006 Sterling dump/plow/sander for \$25,000 plus safety and emissions testing. The total cost to be on the road is estimated at \$30,000 plus tax. This vehicle is an automatic, single axle, directional front plow that is better suited to our streets than the 2003 Mack dual axle. If this truck is purchased it will be the primary snow vehicle till spring and the Mack will be a backup. If the 2011 Freightliner is ultimately repaired we would continue with two older trucks suited to our needs and sell the 2003 Mack. Long-term planning for a new truck would continue with the goal of taking delivery by fall of 2026.
